### Financial Hardship guidelines relating to Freedom of Information Application Fees

#### **Objective**

To provide assistance to members of the community who can genuinely demonstrate financial hardship in relation to the Freedom of Information application fee.

Council recognises that members of the community may at times have difficulty in paying Freedom of Information application fees and is therefore committed to providing mechanisms to support these individuals.

#### Who is eligible?

Any member of the community who submits a valid Freedom of Information request is eligible to apply for a waiver or reduction of this application fee.

Section 17(2B) of the *Freedom of Information Act 1982* (the Act) provides Council with the ability to waive or reduce the payment of the Freedom of Information application fee on the grounds of hardship and subject to any conditions determined by the Council.

#### What is Financial Hardship?

The Macquarie Dictionary (2<sup>nd</sup> edition, 1995) defines hardship as "a condition that bears hard upon one: severe toil, trial, or oppression or need".

An applicant must be able to demonstrate to Council that they are experiencing financial hardship or that payment of the Freedom of Information application fee would cause them to suffer financial hardship.

In order to determine hardship, Council may request the applicant to provide further evidence or information, financial or otherwise before considering financial hardship assistance. This information may include such documentation as a health care card, bank statements, or a statutory declaration outlining why payment would cause the applicant financial hardship.

An applicant seeking assistance is required to complete the Financial Hardship Application Assessment form provided below.
