

## Campaspe Youth GO! Grants - Terms and Conditions

### 1. Eligibility

**Eligible Applicants:** Schools, community groups and organisations that intend to host youth-led events or activities for young people aged 12 to 25 within Campaspe Shire are eligible to apply.

**Nature of Events/Activities:** Events and activities must be alcohol, smoke and drug-free, accessible to all young people, designed to foster social connection, positive well-being, and youth empowerment.

### 2. Application Process

**Submission:** Applications must be completed and submitted online via the council's website.

**Deadline:** Applications close at midnight on Sunday, 19 May 2024.

**Required Information:** All required fields in the application form must be completed. Incomplete applications may not be considered.

**Confirmation:** Applicants will receive a confirmation of their application via the email provided.

### 3. Funding

**Funding Amount:** Grants of up to \$1,000 per application are available.

**Use of Funds:** Grant funds must be used for the purposes outlined in the application, focusing on youth participation, development and celebration in accordance with the principles of the Victorian Government's Engage! initiative.

### 4. Event/Activity Requirements

**Deadline for Event/Activity Completion:** All funded events or activities must take place before 10 November 2024.

**Reporting:** Grant recipients may be required to submit a report detailing the usage of the funds and evaluating the impact of the event on the youth.

### 5. Assessment and Notification

**Assessment Process:** Applications will be assessed by the Campaspe Youth Action Group (YAG), supported by the Community Development Officer.

**Notification of Results:** Applicants will be informed of the outcome by Friday, 7 June 2024.

### 6. General Conditions

**Changes to Event/Activity:** Significant modifications to the scope or nature of the funded events or activities must be reported to and approved by the Council's Youth Community Development Officer before implementation.

**Compliance:** Recipients must ensure all activities comply with local laws and regulations.
