Annual Landing Fee Permit Application

Echuca Aerodrome (YECH)

1 July 2023 to 30 June 2024

If this application is granted, then the aircraft specified below will be permitted to use Echuca Aerodrome without incurring additional usage charges during the period covered by the permit(s).

Each permit will apply to only one aircraft. If permits are sought for more than one aircraft then a separate application must be submitted for each aircraft.¹

Once you have completed the form, print and sign it. Then scan and email the signed form to Avdata or send it by post (contact details below).

If this application is received before 10 August 2023, then the stated annual fee will be charged and the permit will apply to all landings and training usages by the nominated aircraft from 1 July 2023 to 30 June 2024.

If a late application is approved, then a pro-rata fee will be charged based on the number of months (including the current month) remaining in the financial year, and the permit will apply to all landings and training usages during this reduced period. Note that a minimum of 3 months payment is required, applications are to be received by 10th April 2024.

The fees for airport usage permits for 2023-24 are published by Campaspe Shire Council at https://www.campaspe.vic.gov.au/Our-council/Documents/Budgets. Due to the proposed closure of the main aerodrome runway during 2023-24, the annual access fee will be reduced by 50%. If the main aerodrome runway is closed for more than six months then council will arrange the relevant reimbursement. If the main aerodrome runway is closed for less than six months then council will not require any additional payment.
